Armond L. Law, 88, passed away on Tuesday, February 23, 2016, after sustaining injuries from a recent fall. The family will visit with friends on Thursday, February 25, 2016, at 1:00 p.m. in the Sanctuary at First Baptist Church of Haynesville. The Funeral Service will also be on Thursday, February 25, 2016, at 2:00 p.m. at First Baptist Church of Haynesville. Interment will be in Marshallville City Cemetery immediately following the service.
